

# Submit your tax return online, by mobile, text message or phone!

You can then get a tax refund before Midsommer.



## Submit your tax return simply and securely

**It's simple.** Before you start, check that all pre-printed amounts on your tax return are correct. The codes you need in order to approve the information appear at the top of the specification you received along with your tax return form.

**It's secure.** You use your personal security codes. You also find out right away whether your tax return was received.

#### Personal security codes

You can submit your tax return online using your personal security codes if you want to make deductions for travel to and from work or only need to approve the information on your return.

#### Do you have an e-ID?

With an e-ID, you can do a lot more:

- Change or add information
- Fill out and submit supplement K2 if you are voluntarily reversing a deferment or have a preliminary deferment that is to be final
- Fill out and submit supplement K4 if you have sold shares
- Fill out and submit supplement K5 if you have sold a single-family dwelling
- Fill out and submit supplement K6 if you have sold an owner-occupied flat
- Fill out and submit trader supplements NE, NEA and N8, as well as the supplement K10 and VAT supplement
- Fill out the results from supplement N3a
- Fill out and submit supplement K47 (homerelevant work and services)
- Report earnings from renting out residential property.

If you submit your tax return using an e-ID, you do not need any personal security codes from the Swedish Tax Agency.

**What to do:** Go to [www.skatteverket.se](http://www.skatteverket.se) (**Logga in, e-tjänster → Välj e-tjänst → Inkomstdeklaration 1**).

Follow the instructions on what to do next.

### Mobile

## Text message

– send a text message to 71144

#### What to do:

- Enter your Swedish personal identification number (10 digits)

**Example: 5803012805 99999999**

- Type a space
- Enter your signature code (8 digits) – the code is on the specification for your tax return
- Send you text message to 71144. You will receive a text message back within 10 minutes saying, "Din deklaration har nu kommit in till Skatteverket" (Your tax return has now been submitted to the Swedish Tax Agency).

## Phone – Dial 020-567 100

A recorded voice will tell you what to keep in mind when submitting your tax return by phone. You can stop the message whenever you like by pressing star (\*). The message will be re-read from the beginning.

#### What to do:

- If you want to start submitting your tax return, **press 1**.
- If you would like more information, **press 2**. To end the call, **press 9**.

#### After pressing 1, you will hear the following:

- You have chosen to submit your tax return.
- Enter your Swedish personal identification number (10 digits).
- Then press hash (#).
- Enter your identification code (8 digits).
- Then press hash (#).
- If all the amounts are correct, you can now submit your tax return by entering your signature code.
- Enter your signature code (8 digits).
- Then press hash (#).
- Your tax return has now been submitted to the Swedish Tax Agency – thank you for using our self-service telephone.

If you aren't sure whether your tax return has been received, you may call us again. Once you have entered your personal identity number and codes, you will hear this message. "You have already submitted your tax return".

**Please note: If you submit your tax return online, by text message or phone, do not send any paper forms to us.**



# Tax refund before Midsummer?



If you are employed or draw a pension you can get a tax refund as early as June. But to be sure of this you must **(by 2 May 2011 at the latest)**

- submit your tax return online, by mobile, text message or phone
- give us your bank account number, unless you have already done so.
