## Summary

This document describes the XML format used for electronic filing of income statements.

## 1 Document information

### 1.1 Target group

This document is intended for software companies and information providers using their own systems to generate income statement files. The technical description is available only at the Skatteverket web site (ref[2]); it is not available in print.

### 1.2 Terms and definitions

**XML** = eXtensible Markup Language. A standard for structured text based representation of information.

**XML Schema** = A set of rules describing permitted syntax and grammar in an XML document. A schema file has the suffix .xsd.

**Parse** = Divide a text into parts and interpret their meaning.

**Meta data** = Data about data, that is, a description or statement about a piece of data.

## 2 Table description

This document describes the terms included in the electronic filing of income statements.

The XML schema (ref[1], including the XML string, are based on the details in this description.

Explanation of the columns in the following tables:

- Term/Field
  - Description: Description or field name from the corresponding form.
  - Code: Field code in applicable cases.
- Element name in XML: The element found in the XML schema.
- No.: Number of occurrences of the current group/term in the enclosing group. The following variants occur:
  - 0-1: Zero or one occurrence, i.e., the group/term is not compulsory. Marked "minOccurs=""0"" in the schema. The description column specifies when the group/term should and should not be notified.
  - 1: One occurrence, i.e., the group/term is compulsory. No marking the schema (default).
  - 0-n: Zero or more occurrences. Applies only to groups. Marked "minOccurs=""0"" maxOccurs=""unbounded"" in the schema.
  - 1-n: One or more occurrences. Applies only to groups. Marked "maxOccurs=""unbounded"" in the schema.
- Type: Specifies if it is a group ("Grp") or a term with a reference to the value store (Appendix 1).
- Controls
  - ID: Identification label applied to the control.
  - Description: Textual description of the control.



## 3 General information

### 3.1 Validation against XML-schema

Generated XML files can be validated against an XML schema published in accordance with ref [1]. Skatteverket's schema layer is a common storage area which facilitates reuse and access of Skatteverket's public XML schemas. The schema is structured in the following way:



### 3.2 Character set

Skatteverket supports the UTF-8 character set for income statement files (8-bit Unicode transformation format).


### 3.3 Suffix

It has been mandatory in previous versions of the XML-files to use a suffix (only the suffix "ku:" until recently). This is, from schema version 2.0 and onward, not necessary. Files using a (any) suffix and files using no suffix will pass our validation. The header must state the suffix used or if the file is not using suffix. How this can be done is shown in appendix 4, Example files.




## 6 Form entries
